COMPLAINT FILING PROCESS

CONSUMERS CAN SUBMIT COMPLAINTS ONLINE OR VIA MAIL, PROVIDING NECESSARY DETAILS ABOUT THE TRANSACTION AND THE ISSUE. THE BUREAU REVIEWS THE COMPLAINT TO ENSURE IT FALLS WITHIN ITS JURISDICTION BEFORE CONTACTING THE BUSINESS INVOLVED.

BUSINESS RESPONSE AND MEDIATION
