IT ESTABLISHES POLICIES, APPROVES CURRICULUM STANDARDS, AND ENSURES THAT THE DISTRICT COMPLIES WITH EDUCATIONAL LAWS AND REGULATIONS. THE BOARD ACTS AS A LIAISON BETWEEN THE COMMUNITY AND THE SCHOOL DISTRICT, FOSTERING TRANSPARENCY AND ACCOUNTABILITY. IT MEETS REGULARLY TO DISCUSS AND VOTE ON POLICIES, BUDGETARY MATTERS, AND DISTRICT-WIDE INITIATIVES AIMED AT IMPROVING STUDENT OUTCOMES.

MISSION AND VISION

KEY RESPONSIBILITIES

THE BOARD IS CHARGED WITH SEVERAL CRITICAL RESPONSIBILITIES, INCLUDING:

GOVERNANCE AND ORGANIZATIONAL STRUCTURE

THE GOVERNANCE FRAMEWORK OF THE BIG WALNUT BOARD OF EDUCATION IS DESIGNED TO PROMOTE EFFECTIVE LEADERSHIP AND ACCOUNTABILITY. THE BOARD TYPICALLY CONSISTS OF FIVE MEMBERS ELECTED BY THE LOCAL COMMUNITY, SERVING STAGGERED TERMS TO ENSURE CONTINUITY. BOARD MEMBER ROLES AND TERMS

EACH BOARD MEMBER SERVES A TERM OF FOUR YEARS, WITH ELECTIONS HELD BIENNIALLY TO FILL VACANCIES OR EXPIRED TERMS. THE PRESIDENT PRESIDES OVER MEETINGS, SETS AGENDAS IN COLLABORATION WITH THE SUPERINTENDENT, AND REPRESENTS THE BOARD IN OFFICIAL FUNCTIONS. THE VICE PRESIDENT SUPPORTS THE PRESIDENT AND ASSUMES LEADERSHIP DUTIES WHEN NECESSARY. OTHER MEMBERS CONTRIBUTE BY SERVING ON COMMITTEES, ATTENDING MEETINGS, AND PARTICIPATING IN POLICY DISCUSSIONS.

MEETING SCHEDULE AND PROCEDURES

THE BOARD CONVENES REGULAR MEETINGS, OFTEN ON A MONTHLY BASIS, WHICH ARE OPEN TO THE PUBLIC TO ENSURE TRANSPARENCY. THESE MEETINGS FOLLOW A STRUCTURED AGENDA COVERING REPORTS FROM THE SUPERINTENDENT, COMMITTEE UPDATES, PUBLIC COMMENTS, AND VOTING ON KEY MATTERS. SPECIAL MEETINGS MAY BE CALLED FOR URGENT ISSUES OR STRATEGIC PLANNING SESSIONS. MINUTES FROM EACH MEETING ARE RECORDED AND MADE AVAILABLE TO THE COMMUNITY.

EDUCATIONAL PROGRAMS AND INITIATIVES

These endeavors, which largely rely on market-based thinking, assume that individual schools and teachers have the will and ability to do better, if only prodded by competition and other sticks and carrots. Such attempts overlook flaws in a system developed to provide a "common" education while also subdividing resources to maintain privilege for some. This book traces the history of American education as a foundation to examining persistent weaknesses in education today. Meaningful reform and improvement, which are urgent needs, will require broad, systemic change, based on the engagement of many sectors. This book offers a vision for such reform. Following successful models in other countries suggests options for moving away from current, deeply enmired, systemic inequities, to a system better suited to meeting a broad range of educational needs. A portfolio of diverse schools, regionally administered and held accountable for student learning, presents an option for moving away from inequitable district structures and scatter-shot "choice" options. The critical questions are how to get there from here, and do we have the will to do so? The book concludes with suggestions on how to start the process.
