KEY RESPONSIBILITIES AND DAILY TASKS

CLAIMS PREPARATION AND SUBMISSION

MEDICAL BILLERS PREPARE INSURANCE CLAIMS BY COMPILING CODED INFORMATION, VERIFYING PATIENT INSURANCE DETAILS, AND SUBMITTING CLAIMS ELECTRONICALLY OR VIA PAPER. THEY TRACK CLAIM STATUS AND MANAGE FOLLOW-UPS TO RESOLVE DENIALS OR PAYMENT DISCREPANCIES.
