WHEN TO USE CPT CODE 80053

THIS CODE SHOULD BE USED WHEN THE COMPLETE PANEL OF TESTS IS PERFORMED AS A GROUP. IF ONLY INDIVIDUAL COMPONENTS ARE TESTED, SEPARATE CPT CODES MUST BE USED FOR EACH TEST. LABORATORIES MUST ENSURE THAT THE TESTS BILLED UNDER 80053 CORRESPOND TO THE FULL PANEL TO COMPLY WITH PAYER POLICIES AND AVOID CLAIM DENIALS.
