OVERVIEW OF THE CUSTOMS BROKER EXAM

THE CUSTOMS BROKER EXAM IS ADMINISTERED BY U.S. CUSTOMS AND BORDER PROTECTION (CBP) TO EVALUATE THE KNOWLEDGE AND COMPETENCY OF CANDIDATES APPLYING FOR A CUSTOMS BROKER LICENSE. THIS LICENSURE IS MANDATORY FOR INDIVIDUALS WHO WISH TO ACT AS INTERMEDIARIES BETWEEN IMPORTERS/EXPORTERS AND GOVERNMENT CUSTOMS AUTHORITIES. THE EXAM IS TYPICALLY HELD TWICE A YEAR AND COVERS A BROAD SPECTRUM OF CUSTOMS-RELATED TOPICS. IT CONSISTS OF MULTIPLE-CHOICE QUESTIONS DESIGNED TO TEST THE CANDIDATE'S UNDERSTANDING OF CUSTOMS LAWS, CLASSIFICATION, VALUATION, AND PROCEDURES.

EXAM FORMAT AND STRUCTURE

ELIGIBILITY AND REGISTRATION

TO BE ELIGIBLE TO TAKE THE CUSTOMS BROKER EXAM, CANDIDATES MUST MEET SPECIFIC CRITERIA SET BY CBP, INCLUDING BEING A U.S. CITIZEN AND AT LEAST 21 YEARS OLD. REGISTRATION REQUIRES SUBMITTING AN APPLICATION AND PAYING THE EXAM FEE WITHIN DESIGNATED TIMEFRAMES ANNOUNCED BY CBP. ENTRY PROCEDURES AND DOCUMENTATION
