REASONS FOR HISTORICAL FORGETTING

HISTORICAL FORGETTING OCCURS DUE TO A VARIETY OF FACTORS THAT INFLUENCE WHICH STORIES ARE PRESERVED AND WHICH ARE NEGLECTED. UNDERSTANDING THESE CAUSES IS ESSENTIAL TO GRASP WHY MANY IMPORTANT PEOPLE REMAIN IN OBSCURITY DESPITE THEIR SIGNIFICANT CONTRIBUTIONS.

POWER AND CONTROL OVER HISTORICAL NARRATIVES

THE CONTROL OF HISTORICAL RECORDS OFTEN LIES IN THE HANDS OF DOMINANT GROUPS OR RULING POWERS, WHO SHAPE COLLECTIVE MEMORY TO REINFORCE THEIR AUTHORITY AND VALUES. THIS SELECTIVE RECORDING CAN MARGINALIZE DISSENTING VOICES, MINORITIES, AND THOSE WHO CHALLENGE PREVAILING IDEOLOGIES, LEADING TO THE ERASURE OF MANY INDIVIDUALS FROM OFFICIAL HISTORIES.

LACK OF DOCUMENTATION AND PRESERVATION

IN MANY CASES, HISTORICAL FORGETTING RESULTS FROM THE ABSENCE OF WRITTEN OR MATERIAL EVIDENCE. ILLITERATE POPULATIONS, ORAL TRADITIONS, AND THE DESTRUCTION OF RECORDS THROUGH WARS, NATURAL DISASTERS, OR NEGLECT CONTRIBUTE TO THE LOSS OF HISTORICAL INFORMATION ABOUT CERTAIN PEOPLE OR GROUPS.

SOCIAL AND CULTURAL BIASES

PREJUDICES BASED ON GENDER, RACE, CLASS, OR ETHNICITY OFTEN EXCLUDE CERTAIN PEOPLE FROM MAINSTREAM HISTORIES. WOMEN, INDIGENOUS POPULATIONS, ENSLAVED PERSONS, AND LOWER SOCIAL CLASSES HAVE FREQUENTLY BEEN OVERLOOKED OR MISREPRESENTED BECAUSE DOMINANT HISTORICAL FRAMEWORKS FAVORED ELITE, MALE, AND EUROCENTRIC PERSPECTIVES.

CHANGING VALUES AND HISTORICAL INTEREST

WHAT SOCIETIES VALUE OR FIND INTERESTING CHANGES OVER TIME. SOME FIGURES WHO WERE ONCE PROMINENT MAY FADE INTO OBSCURITY AS CULTURAL PRIORITIES SHIFT, WHILE OTHERS MIGHT BE REDISCOVERED WHEN NEW GENERATIONS REASSESS HISTORICAL IMPORTANCE THROUGH DIFFERENT LENSES.

NOTABLE FORGOTTEN FIGURES IN HISTORY

MANY INDIVIDUALS WHO MADE SIGNIFICANT IMPACTS IN THEIR TIME REMAIN LARGELY UNRECOGNIZED TODAY. HIGHLIGHTING SOME OF THESE FORGOTTEN PEOPLE IN HISTORY HELPS TO ILLUMINATE DIVERSE CONTRIBUTIONS THAT HAVE SHAPED THE WORLD.

HYPATIA OF ALEXANDRIA

HYPATIA WAS A RENOWNED MATHEMATICIAN, ASTRONOMER, AND PHILOSOPHER IN ANCIENT ALEXANDRIA DURING THE 4TH CENTURY CE. DESPITE HER INTELLECTUAL ACHIEVEMENTS AND LEADERSHIP, MUCH OF HER LIFE WAS LOST TO HISTORY DUE TO RELIGIOUS AND POLITICAL TURMOIL, WITH HER LEGACY ONLY RECENTLY BEING ACKNOWLEDGED AS A PIONEERING WOMAN IN SCIENCE AND PHILOSOPHY.

IGNAZ SEMMELWEIS

A 19TH-CENTURY HUNGARIAN PHYSICIAN, SEMMELWEIS DISCOVERED THE IMPORTANCE OF HANDWASHING TO PREVENT PUERPERAL FEVER IN MATERNITY WARDS. HIS IDEAS WERE INITIALLY REJECTED BY THE MEDICAL COMMUNITY, AND HE DIED WITHOUT RECOGNITION. TODAY, HE IS CREDITED AS A PIONEER OF ANTISEPTIC PROCEDURES.

SYBIL LUDINGTON

OFTEN CALLED THE FEMALE PAUL REVERE, SYBIL LUDINGTON WAS A TEENAGE HEROINE DURING THE AMERICAN REVOLUTIONARY WAR WHO RODE THROUGH THE NIGHT TO ALERT COLONIAL MILITIA OF BRITISH TROOP MOVEMENTS. HER COURAGEOUS ACT WAS OVERSHADOWED BY MALE COUNTERPARTS AND REMAINS RELATIVELY UNKNOWN IN POPULAR HISTORY.

MARY ANNING

A 19TH-CENTURY FOSSIL HUNTER AND PALEONTOLOGIST FROM ENGLAND, MARY ANNING MADE CRITICAL DISCOVERIES THAT CONTRIBUTED TO THE UNDERSTANDING OF PREHISTORIC LIFE. DESPITE HER CONTRIBUTIONS, SHE WAS LARGELY EXCLUDED FROM SCIENTIFIC CIRCLES DUE TO HER GENDER AND SOCIAL STATUS.

FORGOTTEN GROUPS AND COMMUNITIES

BEYOND INDIVIDUAL FIGURES, ENTIRE COMMUNITIES HAVE BEEN MARGINALIZED OR FORGOTTEN WITHIN HISTORICAL ACCOUNTS. RECOGNIZING THESE GROUPS IS ESSENTIAL FOR A COMPREHENSIVE UNDERSTANDING OF HISTORY.

INDIGENOUS PEOPLES AND THEIR HISTORIES

MANY INDIGENOUS POPULATIONS AROUND THE WORLD HAVE HAD THEIR HISTORIES SUPPRESSED OR DISTORTED THROUGH COLONIZATION, FORCED ASSIMILATION, AND CULTURAL DESTRUCTION. THEIR RICH TRADITIONS, GOVERNANCE SYSTEMS, AND INNOVATIONS OFTEN REMAIN UNDERREPRESENTED IN NATIONAL NARRATIVES.

ENSLAVED AND OPPRESSED POPULATIONS

THE EXPERIENCES AND CONTRIBUTIONS OF ENSLAVED PEOPLES AND OPPRESSED MINORITIES FREQUENTLY GO UNACKNOWLEDGED IN MAINSTREAM HISTORY. THEIR RESILIENCE, RESISTANCE, AND CULTURAL INFLUENCE HAVE BEEN VITAL TO SOCIETAL DEVELOPMENT BUT ARE OFTEN OMITTED OR MINIMIZED.

WOMEN IN HISTORY

WOMEN HAVE HISTORICALLY FACED SYSTEMIC BARRIERS TO RECOGNITION IN POLITICS, SCIENCE, ART, AND OTHER DOMAINS. THEIR ACHIEVEMENTS HAVE BEEN OVERSHADOWED BY MALE CONTEMPORARIES, LEADING TO WIDESPREAD UNDERREPRESENTATION IN HISTORICAL RECORDS.

HISTORICAL REVISIONISM AND INCLUSIVE SCHOLARSHIP

HISTORIANS INCREASINGLY CHALLENGE TRADITIONAL NARRATIVES BY INCORPORATING DIVERSE PERSPECTIVES AND CRITICALLY ANALYZING SOURCES. THIS REVISIONIST APPROACH UNCOVERS NEGLECTED STORIES AND REASSESSES THE SIGNIFICANCE OF OVERLOOKED INDIVIDUALS AND GROUPS.

ARCHIVES, ORAL HISTORIES, AND DIGITAL PRESERVATION

NEW METHODOLOGIES SUCH AS COLLECTING ORAL HISTORIES AND DIGITIZING ARCHIVES HAVE EXPANDED ACCESS TO MATERIALS RELATED TO FORGOTTEN PEOPLE. THESE TOOLS PRESERVE INTANGIBLE CULTURAL HERITAGE AND DEMOCRATIZE HISTORICAL INFORMATION.

PUBLIC HISTORY AND COMMEMORATIVE PROJECTS

MUSEUMS, MONUMENTS, AND PUBLIC EDUCATION INITIATIVES NOW OFTEN EMPHASIZE THE CONTRIBUTIONS OF MARGINALIZED

'FORGOTTEN PEOPLE' IN HISTORY REFER TO INDIVIDUALS OR GROUPS WHOSE CONTRIBUTIONS, STORIES, OR EXPERIENCES HAVE BEEN OVERLOOKED, MARGINALIZED, OR ERASED FROM MAINSTREAM HISTORICAL NARRATIVES.

WHY ARE SOME PEOPLE FORGOTTEN IN HISTORY?

PEOPLE MAY BE FORGOTTEN DUE TO FACTORS SUCH AS SOCIAL INEQUALITY, LACK OF WRITTEN RECORDS, BIASED HISTORICAL PERSPECTIVES, COLONIALISM, RACISM, AND THE DOMINANCE OF CERTAIN CULTURAL NARRATIVES OVER OTHERS.

CAN YOU NAME AN EXAMPLE OF A FORGOTTEN HISTORICAL FIGURE?

ONE EXAMPLE IS MARY ANNING, A 19TH-CENTURY FOSSIL HUNTER WHOSE SIGNIFICANT CONTRIBUTIONS TO PALEONTOLOGY WERE LARGELY UNRECOGNIZED DURING HER LIFETIME BECAUSE SHE WAS A WOMAN FROM A LOWER SOCIAL CLASS.

HOW DOES FORGETTING CERTAIN PEOPLE AFFECT OUR UNDERSTANDING OF HISTORY?

FORGETTING CERTAIN PEOPLE LEADS TO A SKEWED OR INCOMPLETE UNDERSTANDING OF HISTORY, OFTEN PERPETUATING STEREOTYPES AND IGNORING DIVERSE PERSPECTIVES THAT ARE ESSENTIAL FOR A COMPREHENSIVE AND ACCURATE VIEW OF THE PAST.

WHAT EFFORTS ARE BEING MADE TO RECOGNIZE FORGOTTEN PEOPLE IN HISTORY?

EFFORTS INCLUDE ACADEMIC RESEARCH, PUBLIC HISTORY PROJECTS, INCLUSION OF DIVERSE VOICES IN EDUCATION, DOCUMENTARIES, MUSEUM EXHIBITIONS, AND DIGITAL ARCHIVES AIMED AT RECOVERING AND HIGHLIGHTING MARGINALIZED HISTORIES.

HOW CAN INDIVIDUALS HELP BRING ATTENTION TO FORGOTTEN PEOPLE IN HISTORY?

INDIVIDUALS CAN HELP BY RESEARCHING AND SHARING LESSER-KNOWN STORIES, SUPPORTING INCLUSIVE HISTORY EDUCATION, ADVOCATING FOR DIVERSE REPRESENTATION IN MEDIA AND MUSEUMS, AND ENGAGING WITH COMMUNITY HISTORY PROJECTS.

ARE THERE SPECIFIC GROUPS THAT ARE OFTEN FORGOTTEN IN HISTORICAL RECORDS?

YES, GROUPS FREQUENTLY FORGOTTEN INCLUDE INDIGENOUS PEOPLES, WOMEN, ENSLAVED INDIVIDUALS, COLONIZED POPULATIONS, WORKING-CLASS COMMUNITIES, AND LGBTQ+ INDIVIDUALS, AMONG OTHERS.

WHAT ROLE DOES TECHNOLOGY PLAY IN UNCOVERING FORGOTTEN HISTORIES?

forgotten people in history: Queer Jewish Groups in Europe (1972-1990s) Jan Wilkens, 2025-03-31 In the 1970s, queer Jews became excited by the developments of the Gay Liberation Movement in both the US and Europe. Until then, they were not able to express their queerness in Jewish communities and hoped for new inclusive spaces. Yet, they quickly realized that the movement was not as welcoming as anticipated. Thus, they started to organize: in February 1972, the world's first queer Jewish group became publicly visible in London with its symposium The Jewish Homosexual in Society. The Jewish Gay Group began tackling the exclusion of non-heteronormative Jews in British Jewish and queer communities. Soon after, two more queer Jewish groups formed: Beit Haverim (House of Friends) in Paris and Sjalhomo (a neologism of shalom and homosexual) in Amsterdam. Besides their goal of emancipation, these groups brought together their members based on shared experiences as both Jewish and queer, opening up much needed spaces for social encounters. The groups also established a Europe-wide support network that enabled international collaboration for more than a decade. This study archives these groups' histories and that of their network. By doing so, it broadens prevalent narratives of Europe's post-World War II Jewry and queers the discipline of Jewish History.

Unfortunately, the knowledge of to-day does not permit us to follow this theoretical obligation. We now know that the gaps in the history of human evolution as accessible to us to-day, vastly exceed the recorded chapters; that, in short, the period with which history proper has, at present, to content itself, is a mere moment in comparison with the vast reaches of time which, in recognition of our ignorance, we term "prehistoric." But this recognition of

limitations of our knowledge is a quite recent growth—no older, indeed, than a half century. Prior to 1859 the people of Christendom rested secure in the supposition that the chronology of man's history was fully known, from the very year of his creation. One has but to turn to the first chapter of Genesis to find in the margin the date 4004 B.C., recorded with all confidence as the year of man's first appearance on the globe. One finds there, too, a brief but comprehensive account of the manner of his appearance, as well as of the creation of the earth itself, his abiding-place. Until about half a century ago, as has just been said, the peoples of our portion of the globe rested secure in the supposition that this record and this date were a part of our definite knowledge of man's history. Therefore, one finds the writers of general histories of the earlier days of the nineteenth century beginning their accounts with the creation of man, B.C. 4004, and coming on down to date with a full and seemingly secure chronology. Our knowledge of the world and of man's history has come on by leaps and bounds since then, with the curious result that to-day no one thinks of making any reference to the exact date of the beginnings of human history,—unless, indeed, it be to remark that it probably reaches back some hundreds of thousands of years. The historian can speak of dates anterior to 4004 B.C., to be sure. The Egyptologist is disposed to date the building of the Pyramids a full thousand years earlier than that. And the Assyriologist is learning to speak of the state of civilisation in Chaldea some 6000 or 7000 years B.C. with a certain measure of confidence. But he no longer thinks of these dates as standing anywhere near the beginning of history. He knows that man in that age, in the centres of progress, had attained a high stage of civilisation, and he feels sure that there were some thousands of centuries of earlier time, during which man was slowly climbing through savagery and barbarism, of which we have only the most fragmentary record. He does not pretend to know anything, except by inference, of the “dawnings of civilisation.” Whichever way he turns in the centres of progress, such as China, Egypt, Chaldea, India, he finds the earliest accessible records, covering at best a period of only eight or ten thousand years, giving evidence of a civilisation already far advanced. Of the exact origin of any one of the civilisations with which he deals he knows absolutely nothing. “The Creation of Man,” with its fixed chronology, is a chapter that has vanished from our modern histories.
