GEORGIA LAW REQUIRES NOTARIES TO SECURE A \$10,000 SURETY BOND TO PROTECT THE PUBLIC FROM POTENTIAL NEGLIGENCE OR MISCONDUCT. THE BOND MUST BE PURCHASED FROM A LICENSED SURETY COMPANY AND IS VALID FOR THE DURATION OF THE NOTARY COMMISSION. PROOF OF THIS BOND IS SUBMITTED ALONGSIDE THE APPLICATION TO FINALIZE THE COMMISSIONING PROCESS.

RECEIVING THE COMMISSION AND NOTARY SUPPLIES

ONCE APPROVED, APPLICANTS RECEIVE THEIR OFFICIAL NOTARY COMMISSION CERTIFICATE FROM THE STATE. THEY MUST THEN ACQUIRE NECESSARY NOTARY SUPPLIES SUCH AS A SEAL OR STAMP AND A NOTARY JOURNAL. THESE TOOLS ARE ESSENTIAL FOR PERFORMING NOTARIZATIONS CORRECTLY AND MAINTAINING ACCURATE RECORDS AS REQUIRED BY GEORGIA LAW.
