THEY MONITOR CONTRACTOR PERFORMANCE, VERIFY DELIVERABLES, AND MAINTAIN DOCUMENTATION TO SUPPORT CONTRACT ADMINISTRATION. THIS POSITION REQUIRES A THOROUGH UNDERSTANDING OF GOVERNMENT PROCUREMENT REGULATIONS, TECHNICAL KNOWLEDGE RELEVANT TO THE CONTRACT SCOPE, AND STRONG COMMUNICATION SKILLS. CORs ARE RESPONSIBLE FOR SAFEGUARDING GOVERNMENT INTERESTS AND ENSURING THAT TAXPAYER FUNDS ARE USED EFFICIENTLY AND EFFECTIVELY.

KEY RESPONSIBILITIES OF A COR

CONTRACTING OFFICER REPRESENTATIVES MUST ADHERE TO SPECIFIC RESPONSIBILITIES TO MAINTAIN CONTRACT INTEGRITY AND COMPLIANCE. THESE INCLUDE:

- MONITORING CONTRACT PERFORMANCE AND PROGRESS REPORTS
- REVIEWING AND APPROVING INVOICES AND PAYMENTS
- DOCUMENTING CONTRACT MODIFICATIONS AND COMMUNICATIONS
- ENSURING CONTRACTORS MEET QUALITY AND DELIVERY STANDARDS

- REPORTING POTENTIAL CONTRACT ISSUES TO THE CONTRACTING OFFICER

IMPORTANCE OF PROPER TRAINING FOR CORs

PROPER TRAINING EQUIPS CORs WITH THE KNOWLEDGE AND SKILLS NECESSARY TO MANAGE CONTRACTS EFFECTIVELY AND MITIGATE RISKS.
