INITIAL INVENTORY AND SUPPLIES

STOCKING UP ON YOGURT MIX, TOPPINGS, CUPS, SPOONS, AND CLEANING SUPPLIES IS ESSENTIAL BEFORE OPENING DAY. THE INITIAL INVENTORY MUST BE SUFFICIENT TO MEET EXPECTED DEMAND DURING THE LAUNCH PHASE. BULK PURCHASING MAY REDUCE UNIT COSTS BUT REQUIRES MORE UPFRONT CAPITAL.

INVENTORY REPLENISHMENT

INSURANCE
