PROSPECTIVE LICENSEES MUST POSSESS A DEGREE FROM A PHYSICAL THERAPY PROGRAM ACCREDITED BY THE COMMISSION ON ACCREDITATION IN PHYSICAL THERAPY EDUCATION (CAPTE). THIS ACCREDITATION ENSURES THAT THE CURRICULUM AND CLINICAL EXPERIENCE MEET NATIONALLY RECOGNIZED STANDARDS. ILLINOIS REQUIRES CANDIDATES TO HAVE EARNED EITHER A DOCTOR OF PHYSICAL THERAPY (DPT) DEGREE OR AN EQUIVALENT GRADUATE DEGREE IN PHYSICAL THERAPY FROM AN ACCREDITED INSTITUTION.

ACCREDITED PROGRAMS AND DEGREE EQUIVALENCY

THE ILLINOIS REGULATORY BODY STRICTLY ENFORCES THE ACCREDITATION CRITERION TO MAINTAIN HIGH PROFESSIONAL STANDARDS. GRADUATES FROM FOREIGN INSTITUTIONS MUST HAVE THEIR CREDENTIALS EVALUATED BY A RECOGNIZED CREDENTIALING AGENCY TO VERIFY EQUIVALENCY TO CAPTE STANDARDS. THIS STEP IS VITAL BEFORE PROCEEDING WITH THE LICENSING APPLICATION. ADDITIONALLY, COURSEWORK AND CLINICAL HOURS MUST ALIGN WITH ILLINOIS REQUIREMENTS TO QUALIFY FOR LICENSURE.

CLINICAL EXPERIENCE AND SUPERVISED PRACTICE

CLINICAL TRAINING IS A FUNDAMENTAL PART OF PHYSICAL THERAPY EDUCATION. ILLINOIS MANDATES COMPLETION OF SPECIFIC CLINICAL HOURS UNDER SUPERVISED PRACTICE, INTEGRATED WITHIN THE ACCREDITED DEGREE PROGRAM. THIS PRACTICAL EXPERIENCE EQUIPS CANDIDATES WITH HANDS-ON SKILLS ESSENTIAL FOR SAFE AND EFFECTIVE PATIENT CARE. THE CLINICAL COMPONENTS MUST BE DOCUMENTED AND VERIFIED AS PART OF THE LICENSING APPLICATION.

EXAMINATION REQUIREMENTS

PASSING THE APPROPRIATE EXAMINATIONS IS A CRITICAL STEP IN FULFILLING THE ILLINOIS PHYSICAL THERAPY LICENSE REQUIREMENTS. THE STATE REQUIRES CANDIDATES TO SUCCESSFULLY COMPLETE THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE), ADMINISTERED BY THE FEDERATION OF STATE BOARDS OF PHYSICAL THERAPY (FSBPT). THE NPTE ASSESSES THE CANDIDATE'S KNOWLEDGE AND COMPETENCE TO PRACTICE PHYSICAL THERAPY SAFELY AND EFFECTIVELY.

NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE)

THE NPTE IS A COMPREHENSIVE EXAM COVERING VARIOUS DOMAINS OF PHYSICAL THERAPY PRACTICE, INCLUDING PATIENT MANAGEMENT, THERAPEUTIC INTERVENTIONS, AND PROFESSIONAL RESPONSIBILITIES. ILLINOIS MANDATES A PASSING SCORE DETERMINED BY THE FSBPT. CANDIDATES SHOULD PREPARE THOROUGHLY AND MAY TAKE THE EXAM ONLY AFTER MEETING EDUCATIONAL PREREQUISITES.

JURISPRUDENCE EXAMINATION

IN ADDITION TO THE NPTE, ILLINOIS REQUIRES APPLICANTS TO PASS A JURISPRUDENCE EXAMINATION OR COMPLETE AN ONLINE MODULE COVERING STATE LAWS, RULES, AND REGULATIONS GOVERNING PHYSICAL THERAPY PRACTICE. THIS REQUIREMENT ENSURES THAT LICENSEES UNDERSTAND THE LEGAL AND ETHICAL FRAMEWORK WITHIN WHICH THEY MUST OPERATE. THE JURISPRUDENCE COMPONENT IS DESIGNED TO PROTECT PUBLIC HEALTH AND MAINTAIN PROFESSIONAL STANDARDS.

APPLICATION PROCESS AND DOCUMENTATION

MEETING EDUCATIONAL AND EXAMINATION REQUIREMENTS IS FOLLOWED BY SUBMITTING A DETAILED APPLICATION TO THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION. THE APPLICATION PROCESS IS STRUCTURED TO VERIFY ELIGIBILITY AND ENSURE COMPLIANCE WITH ALL LICENSING CRITERIA.

REQUIRED DOCUMENTATION

APPLICANTS MUST PROVIDE SEVERAL KEY DOCUMENTS, INCLUDING:

- PROOF OF GRADUATION FROM AN ACCREDITED PHYSICAL THERAPY PROGRAM
- OFFICIAL NPTE SCORE REPORT
- VERIFICATION OF CLINICAL EXPERIENCE AND SUPERVISED PRACTICE
- COMPLETED APPLICATION FORM WITH ALL REQUIRED PERSONAL AND PROFESSIONAL INFORMATION
- PROOF OF PASSING THE JURISPRUDENCE EXAMINATION OR COMPLETION OF THE STATE'S ONLINE MODULE

ALL DOCUMENTS MUST BE SUBMITTED IN THE FORMAT SPECIFIED BY THE IDFPR. INCOMPLETE OR INACCURATE SUBMISSIONS MAY DELAY THE LICENSURE PROCESS.

APPLICATION FEES AND PROCESSING TIME

APPLICANTS ARE REQUIRED TO PAY A NON-REFUNDABLE APPLICATION FEE AT THE TIME OF SUBMISSION. THE FEE AMOUNT IS SUBJECT TO CHANGE BUT GENERALLY COVERS THE ADMINISTRATIVE COSTS OF PROCESSING AND VERIFICATION. PROCESSING TIME CAN VARY BUT TYPICALLY RANGES FROM SEVERAL WEEKS TO A FEW MONTHS, DEPENDING ON THE COMPLETENESS OF THE APPLICATION AND VERIFICATION PROCEDURES.

BACKGROUND CHECKS AND LEGAL CONSIDERATIONS

AS PART OF THE ILLINOIS PHYSICAL THERAPY LICENSE REQUIREMENTS, ALL APPLICANTS MUST UNDERGO A CRIMINAL BACKGROUND CHECK. THIS MEASURE IS INTENDED TO PROTECT PATIENTS AND ENSURE THAT LICENSED PROFESSIONALS MAINTAIN ETHICAL STANDARDS. FINGERPRINTING AND CRIMINAL HISTORY REVIEW

THE IDFPR REQUIRES FINGERPRINT SUBMISSION THROUGH AN APPROVED VENDOR OR LAW ENFORCEMENT AGENCY. THE BACKGROUND CHECK COVERS BOTH STATE AND FEDERAL DATABASES. ANY CRIMINAL CONVICTIONS OR DISCIPLINARY ACTIONS MAY AFFECT ELIGIBILITY FOR LICENSURE. APPLICANTS ARE ADVISED TO DISCLOSE ANY RELEVANT INFORMATION TRUTHFULLY TO AVOID DELAYS OR DENIALS.

DISCIPLINARY ACTIONS AND DENIAL OF LICENSE

ILLINOIS MAINTAINS STRICT POLICIES REGARDING PROFESSIONAL CONDUCT. PAST DISCIPLINARY ACTIONS, CRIMINAL OFFENSES RELATED TO HEALTHCARE, OR FRAUDULENT ACTIVITIES CAN LEAD TO LICENSE DENIAL OR REVOCATION. THE STATE RESERVES THE RIGHT TO REFUSE LICENSURE TO APPLICANTS WHO DO NOT MEET THE CHARACTER AND FITNESS REQUIREMENTS. UNDERSTANDING THESE LEGAL CONSIDERATIONS IS CRUCIAL WHEN APPLYING.

LICENSE RENEWAL AND CONTINUING EDUCATION

OBTAINING A PHYSICAL THERAPY LICENSE IN ILLINOIS IS NOT A ONE-TIME EVENT; MAINTAINING LICENSURE REQUIRES ONGOING COMPLIANCE WITH RENEWAL AND CONTINUING EDUCATION REQUIREMENTS. THE STATE MANDATES PERIODIC LICENSE RENEWAL TO ENSURE THAT PRACTITIONERS REMAIN CURRENT WITH EVOLVING STANDARDS AND BEST PRACTICES.

RENEWAL PERIOD AND REQUIREMENTS

ILLINOIS PHYSICAL THERAPY LICENSES MUST BE RENEWED EVERY TWO YEARS. RENEWAL APPLICATIONS MUST BE SUBMITTED BEFORE THE EXPIRATION DATE TO AVOID PENALTIES OR LICENSE LAPSE. THE PROCESS INCLUDES VERIFICATION OF COMPLETED CONTINUING EDUCATION CREDITS AND PAYMENT OF RENEWAL FEES.

CONTINUING EDUCATION OBLIGATIONS

- COMPLETION OF AT LEAST 30 HOURS OF APPROVED CONTINUING EDUCATION EVERY TWO YEARS
- DOCUMENTATION AND RETENTION OF CERTIFICATES FOR AUDIT PURPOSES
- MANDATORY COURSES ON ETHICS AND ILLINOIS LAWS RELATED TO PHYSICAL THERAPY

FAILURE TO COMPLY WITH CONTINUING EDUCATION REQUIREMENTS CAN RESULT IN SUSPENSION OR REVOCATION OF THE LICENSE. THEREFORE, DILIGENT RECORD-KEEPING AND TIMELY RENEWAL ARE CRITICAL FOR ONGOING LICENSURE.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE BASIC ELIGIBILITY REQUIREMENTS TO APPLY FOR A PHYSICAL THERAPY LICENSE IN ILLINOIS?

TO APPLY FOR A PHYSICAL THERAPY LICENSE IN ILLINOIS, CANDIDATES MUST HAVE GRADUATED FROM A CAPTE-ACCREDITED PHYSICAL THERAPY PROGRAM, PASSED THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE), AND COMPLETED AN APPLICATION WITH THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION (IDFPR).

IS PASSING THE NPTE REQUIRED FOR OBTAINING A PHYSICAL THERAPY LICENSE IN ILLINOIS?

YES, PASSING THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE) IS MANDATORY FOR ALL APPLICANTS SEEKING LICENSURE AS A PHYSICAL THERAPIST IN ILLINOIS.

DOES ILLINOIS REQUIRE A JURISPRUDENCE EXAM FOR PHYSICAL THERAPY LICENSURE?

YES, ILLINOIS REQUIRES APPLICANTS TO PASS THE ILLINOIS JURISPRUDENCE EXAMINATION, WHICH TESTS KNOWLEDGE OF STATE LAWS AND REGULATIONS RELATED TO PHYSICAL THERAPY PRACTICE.

ARE THERE ANY CONTINUING EDUCATION REQUIREMENTS TO MAINTAIN A PHYSICAL THERAPY LICENSE IN ILLINOIS?

INTERNATIONALLY EDUCATED PHYSICAL THERAPISTS MUST HAVE THEIR CREDENTIALS EVALUATED BY A CREDENTIALING AGENCY APPROVED BY THE IDFPR AND DEMONSTRATE EQUIVALENCY TO U.S. EDUCATION STANDARDS BEFORE APPLYING FOR LICENSURE IN ILLINOIS.

WHAT IS THE APPLICATION PROCESS FOR A PHYSICAL THERAPY LICENSE IN ILLINOIS?

THE APPLICATION PROCESS INCLUDES SUBMITTING AN ONLINE APPLICATION THROUGH THE IDFPR WEBSITE, PROVIDING OFFICIAL TRANSCRIPTS, PROOF OF NPTE PASSAGE, COMPLETING THE JURISPRUDENCE EXAM, AND PAYING THE REQUIRED FEES.

HOW LONG DOES IT TAKE TO GET A PHYSICAL THERAPY LICENSE IN ILLINOIS AFTER APPLYING?
