ILLINOIS DRIVER'S LICENSING REQUIREMENTS

AGE AND ELIGIBILITY

REQUIRED DOCUMENTATION

TRAFFIC LAWS AND REGULATIONS IN ILLINOIS

SEAT BELT AND CHILD SAFETY LAWS

ILLINOIS LAW REQUIRES ALL VEHICLE OCCUPANTS TO WEAR SEAT BELTS. CHILDREN UNDER THE AGE OF 8 MUST BE SECURED IN AN APPROPRIATE CHILD SAFETY SEAT OR BOOSTER SEAT ACCORDING TO THEIR SIZE AND AGE. DRIVING UNDER THE INFLUENCE (DUI)

UNDERSTANDING THESE LAWS IS CRUCIAL FOR RESPONSIBLE DRIVING AND COMPLIANCE WITH ILLINOIS REGULATIONS.

UNDERSTANDING ILLINOIS ROAD SIGNS AND SIGNALS

COMMON SIGN EXAMPLES

- **STOP SIGN:** A RED OCTAGON INSTRUCTING DRIVERS TO COME TO A COMPLETE STOP.
- **YIELD SIGN:** A RED AND WHITE TRIANGLE REQUIRING DRIVERS TO GIVE THE RIGHT-OF-WAY.
- **SPEED LIMIT SIGN:** INDICATES THE MAXIMUM LEGAL SPEED FOR THAT ROAD SEGMENT.
- **PEDESTRIAN CROSSING:** ALERTS DRIVERS TO AREAS WHERE PEDESTRIANS CROSS THE ROAD.

SAFE DRIVING PRACTICES AND PENALTIES
