ELIGIBILITY REQUIREMENTS FOR THE ILLINOIS REAL ESTATE EXAM

BEFORE SITTING FOR THE ILLINOIS REAL ESTATE EXAM, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA SET BY THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION (IDFPR). THESE REQUIREMENTS ENSURE THAT APPLICANTS POSSESS THE NECESSARY BACKGROUND AND EDUCATION TO PURSUE A CAREER IN REAL ESTATE. UNDERSTANDING ELIGIBILITY IS THE FIRST STEP TOWARD BECOMING A LICENSED REAL ESTATE PROFESSIONAL IN ILLINOIS.

EDUCATIONAL PREREQUISITES

BACKGROUND CHECK AND FINGERPRINTING

APPLICANTS MUST UNDERGO A CRIMINAL BACKGROUND CHECK AND SUBMIT FINGERPRINTS AS PART OF THE LICENSING PROCESS. THIS STEP HELPS MAINTAIN THE INTEGRITY OF THE REAL ESTATE PROFESSION AND ENSURES THAT LICENSEES MEET ETHICAL

STANDARDS. CERTAIN CRIMINAL CONVICTIONS MAY AFFECT ELIGIBILITY, SO IT IS IMPORTANT TO DISCLOSE ALL RELEVANT INFORMATION DURING THE APPLICATION PROCESS.

EXAM STRUCTURE AND CONTENT

MINIMUM PASSING SCORE

TO PASS THE EXAM, CANDIDATES MUST ACHIEVE A SCORE OF AT LEAST 75%. THIS MEANS CORRECTLY ANSWERING AT LEAST 90 OUT OF THE 120 QUESTIONS. BOTH THE NATIONAL AND STATE PORTIONS ARE SCORED TOGETHER, WITH NO SEPARATE MINIMUMS FOR EACH SECTION.

RETAKE POLICY

APPLICANTS WHO DO NOT PASS THE EXAM ON THEIR FIRST ATTEMPT MAY RETAKE IT. ILLINOIS ALLOWS MULTIPLE ATTEMPTS; HOWEVER, CANDIDATES MUST WAIT A SPECIFIED PERIOD BEFORE RETAKING THE EXAM. IT IS RECOMMENDED TO REVIEW STUDY MATERIALS THOROUGHLY BEFORE SCHEDULING A RETAKE TO IMPROVE THE CHANCES OF SUCCESS.

POST-EXAM LICENSING PROCESS

AFTER PASSING THE ILLINOIS REAL ESTATE EXAM, CANDIDATES MUST COMPLETE ADDITIONAL STEPS TO BECOME FULLY LICENSED. THESE PROCEDURES ENSURE THAT NEW LICENSEES MEET ALL PROFESSIONAL REQUIREMENTS.

RECEIVING THE REAL ESTATE LICENSE

ONCE ALL REQUIREMENTS ARE MET AND THE APPLICATION IS APPROVED, THE IDFPR ISSUES THE OFFICIAL REAL ESTATE LICENSE. AT THIS POINT, THE INDIVIDUAL IS AUTHORIZED TO LEGALLY PRACTICE REAL ESTATE WITHIN ILLINOIS UNDER THEIR SPONSORING BROKER.

ADDITIONAL RESOURCES AND CONTINUING EDUCATION

CONTINUING EDUCATION REQUIREMENTS
