# OVERVIEW OF THE ILLINOIS PHYSICAL THERAPY BOARD

THE ILLINOIS PHYSICAL THERAPY BOARD IS A STATE REGULATORY AGENCY RESPONSIBLE FOR OVERSEEING THE PRACTICE OF PHYSICAL THERAPY IN ILLINOIS. IT OPERATES UNDER THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION (IDFPR) AND ENSURES THAT PHYSICAL THERAPISTS ADHERE TO STATE LAWS AND PROFESSIONAL STANDARDS. THE BOARD'S MISSION IS TO PROTECT THE PUBLIC BY LICENSING QUALIFIED PRACTITIONERS, MONITORING COMPLIANCE, AND TAKING DISCIPLINARY ACTION WHEN NECESSARY.

### BOARD COMPOSITION AND AUTHORITY

THE ILLINOIS PHYSICAL THERAPY BOARD CONSISTS OF LICENSED PHYSICAL THERAPISTS, PHYSICAL THERAPIST ASSISTANTS, AND PUBLIC MEMBERS APPOINTED BY THE GOVERNOR. THESE MEMBERS BRING PROFESSIONAL EXPERTISE AND PUBLIC PERSPECTIVE TO THE BOARD'S DECISION-MAKING PROCESSES. THE BOARD HAS THE AUTHORITY TO ESTABLISH RULES, REVIEW APPLICATIONS, CONDUCT HEARINGS, AND IMPOSE SANCTIONS ON PRACTITIONERS WHO VIOLATE REGULATIONS.

### ROLE IN PUBLIC SAFETY AND PROFESSIONAL STANDARDS

PROTECTING PUBLIC SAFETY IS THE BOARD'S PRIMARY GOAL. IT ENFORCES STANDARDS RELATED TO ETHICAL PRACTICE, CLINICAL COMPETENCE, AND PROFESSIONAL CONDUCT. THE BOARD ALSO REVIEWS AND UPDATES RULES TO REFLECT CURRENT BEST PRACTICES IN PHYSICAL THERAPY, ENSURING THAT PRACTITIONERS PROVIDE CARE THAT MEETS CONTEMPORARY HEALTHCARE EXPECTATIONS.

## LICENSING REQUIREMENTS AND APPLICATION PROCESS

LICENSURE BY THE ILLINOIS PHYSICAL THERAPY BOARD IS MANDATORY FOR ANYONE WISHING TO PRACTICE PHYSICAL THERAPY IN ILLINOIS. THE LICENSING PROCESS EVALUATES CANDIDATES' EDUCATION, EXAMINATION PERFORMANCE, AND MORAL CHARACTER TO ENSURE THEY ARE QUALIFIED TO PROVIDE PATIENT CARE.

### EDUCATIONAL AND EXAMINATION CRITERIA

APPLICANTS MUST GRADUATE FROM AN ACCREDITED PHYSICAL THERAPY PROGRAM APPROVED BY THE COMMISSION ON ACCREDITATION IN PHYSICAL THERAPY EDUCATION (CAPTE). ADDITIONALLY, CANDIDATES MUST PASS THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE), WHICH TESTS KNOWLEDGE AND CLINICAL SKILLS ESSENTIAL FOR PRACTICE.

### APPLICATION SUBMISSION AND FEES

The licensure application is submitted through the Illinois Department of Financial and Professional Regulation. Applicants must provide verified transcripts, examination scores, and personal information. The application process includes a fee, which covers administrative costs associated with processing and evaluating credentials.

### BACKGROUND CHECKS AND MORAL CHARACTER EVALUATION

AS PART OF THE APPLICATION, THE ILLINOIS PHYSICAL THERAPY BOARD REQUIRES A CRIMINAL BACKGROUND CHECK TO ENSURE APPLICANTS HAVE NO DISQUALIFYING OFFENSES. THE BOARD ALSO ASSESSES MORAL CHARACTER, WHICH INVOLVES REVIEWING ANY PAST DISCIPLINARY ACTIONS OR LEGAL ISSUES RELATED TO PROFESSIONAL CONDUCT.

## CONTINUING EDUCATION AND LICENSE RENEWAL

MAINTAINING AN ACTIVE PHYSICAL THERAPY LICENSE IN ILLINOIS REQUIRES COMPLIANCE WITH CONTINUING EDUCATION AND RENEWAL REQUIREMENTS ESTABLISHED BY THE ILLINOIS PHYSICAL THERAPY BOARD. THESE MEASURES ENSURE THAT PRACTITIONERS REMAIN CURRENT WITH ADVANCES IN PHYSICAL THERAPY PRACTICE.

## CONTINUING EDUCATION REQUIREMENTS

LICENSED PHYSICAL THERAPISTS MUST COMPLETE A SPECIFIED NUMBER OF CONTINUING EDUCATION UNITS (CEUs) DURING EACH RENEWAL PERIOD. THESE CEUS COVER TOPICS SUCH AS CLINICAL SKILLS, ETHICS, PATIENT SAFETY, AND NEW THERAPEUTIC TECHNIQUES. THE BOARD APPROVES COURSES AND PROVIDERS TO GUARANTEE EDUCATIONAL QUALITY.

### LICENSE RENEWAL PROCESS

LICENSE RENEWAL OCCURS BIENNIALLY AND DEMANDS SUBMISSION OF RENEWAL FORMS, PROOF OF CONTINUING EDUCATION, AND PAYMENT OF RENEWAL FEES. THE ILLINOIS PHYSICAL THERAPY BOARD REVIEWS RENEWALS TO VERIFY COMPLIANCE BEFORE GRANTING LICENSE EXTENSIONS.

### LATE RENEWAL AND REINSTATEMENT

PRACTITIONERS WHO FAIL TO RENEW THEIR LICENSE ON TIME MAY FACE PENALTIES OR BE REQUIRED TO UNDERGO REINSTATEMENT PROCEDURES. THE BOARD OUTLINES SPECIFIC STEPS FOR LATE RENEWAL, WHICH MAY INCLUDE ADDITIONAL EDUCATION OR FEES TO REGAIN LICENSURE.

## COMPLAINT AND DISCIPLINARY PROCEDURES

THE ILLINOIS PHYSICAL THERAPY BOARD INVESTIGATES COMPLAINTS AGAINST LICENSED PHYSICAL THERAPISTS TO UPHOLD PROFESSIONAL STANDARDS AND PROTECT THE PUBLIC FROM UNSAFE OR UNETHICAL PRACTICES. THE BOARD FOLLOWS A STRUCTURED DISCIPLINARY PROCESS WHEN VIOLATIONS ARE SUSPECTED.

## FILING A COMPLAINT

COMPLAINTS CAN BE SUBMITTED BY PATIENTS, COLLEAGUES, EMPLOYERS, OR ANY MEMBER OF THE PUBLIC. THE BOARD REQUIRES DETAILED INFORMATION ABOUT THE ALLEGED MISCONDUCT, INCLUDING DATES, DESCRIPTIONS, AND ANY SUPPORTING DOCUMENTATION. CONFIDENTIALITY IS MAINTAINED THROUGHOUT THE INVESTIGATION.

### INVESTIGATION AND HEARING PROCESS

Upon receiving a complaint, the board conducts a thorough investigation, which may involve interviews, record reviews, and expert consultations. If evidence supports the complaint, a formal hearing is scheduled where the licensee can present a defense. The board evaluates all information before rendering a decision.

### Possible Disciplinary Actions

THE ILLINOIS PHYSICAL THERAPY BOARD HAS SEVERAL OPTIONS FOR DISCIPLINARY ACTION, DEPENDING ON THE SEVERITY OF THE VIOLATION:

- FORMAL REPRIMAND OR CENSURE
- MONETARY FINES
- PROBATION WITH SPECIFIC CONDITIONS
- SUSPENSION OF LICENSE
- REVOCATION OF LICENSE

THESE MEASURES ENSURE ACCOUNTABILITY AND PROMOTE ADHERENCE TO PROFESSIONAL STANDARDS.

## RESOURCES AND SUPPORT FOR PHYSICAL THERAPISTS

THE ILLINOIS PHYSICAL THERAPY BOARD PROVIDES VARIOUS RESOURCES TO SUPPORT LICENSED PHYSICAL THERAPISTS IN MAINTAINING COMPLIANCE AND ADVANCING THEIR PROFESSIONAL DEVELOPMENT. THESE RESOURCES ALSO SERVE TO INFORM THE PUBLIC ABOUT THE PRACTICE OF PHYSICAL THERAPY.

### ONLINE SERVICES AND LICENSING PORTAL

THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION OFFERS AN ONLINE PORTAL WHERE PHYSICAL THERAPISTS CAN APPLY FOR LICENSURE, RENEW LICENSES, SUBMIT CONTINUING EDUCATION DOCUMENTATION, AND CHECK THE STATUS OF THEIR CREDENTIALS. THIS DIGITAL PLATFORM STREAMLINES ADMINISTRATIVE PROCESSES.

### PUBLIC ACCESS AND CONSUMER PROTECTION

THE ILLINOIS PHYSICAL THERAPY BOARD PROVIDES PUBLIC ACCESS TO LICENSE VERIFICATION AND DISCIPLINARY RECORDS. THIS TRANSPARENCY ALLOWS CONSUMERS TO MAKE INFORMED DECISIONS WHEN SELECTING PHYSICAL THERAPY PROVIDERS AND ENHANCES TRUST IN THE PROFESSION.

TO OBTAIN A PHYSICAL THERAPY LICENSE IN ILLINOIS, APPLICANTS MUST GRADUATE FROM AN ACCREDITED PHYSICAL THERAPY PROGRAM, PASS THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE), COMPLETE THE ILLINOIS JURISPRUDENCE EXAM, AND SUBMIT AN APPLICATION ALONG WITH REQUIRED FEES TO THE ILLINOIS PHYSICAL THERAPY BOARD.

# WHAT ARE THE CONTINUING EDUCATION REQUIREMENTS FOR PHYSICAL THERAPISTS IN ILLINOIS?

Physical therapists in Illinois must complete 30 hours of continuing education every two years, including specific hours related to ethics and Illinois laws, as mandated by the Illinois Physical Therapy Board to maintain their license.

### HOW CAN I FILE A COMPLAINT AGAINST A PHYSICAL THERAPIST IN ILLINOIS?

COMPLAINTS AGAINST PHYSICAL THERAPISTS IN ILLINOIS CAN BE FILED WITH THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION (IDFPR), WHICH OVERSEES THE PHYSICAL THERAPY BOARD, BY SUBMITTING A COMPLAINT FORM ONLINE OR VIA MAIL DETAILING THE ISSUE.

### WHAT DISCIPLINARY ACTIONS CAN THE ILLINOIS PHYSICAL THERAPY BOARD TAKE?

THE ILLINOIS PHYSICAL THERAPY BOARD CAN IMPOSE DISCIPLINARY ACTIONS SUCH AS LICENSE SUSPENSION, REVOCATION, FINES, PROBATION, OR REPRIMAND FOR VIOLATIONS OF PROFESSIONAL CONDUCT OR REGULATIONS.

# ARE PHYSICAL THERAPY ASSISTANTS REGULATED BY THE ILLINOIS PHYSICAL THERAPY BOARD?

YES, PHYSICAL THERAPY ASSISTANTS ARE REGULATED BY THE ILLINOIS PHYSICAL THERAPY BOARD, WHICH REQUIRES THEM TO BE LICENSED AND ADHERE TO THE SAME PROFESSIONAL STANDARDS AND CONTINUING EDUCATION REQUIREMENTS.
