In contrast, the reality in low- and middle-income countries (LMICs) is strikingly different, where disparities on accessibility to these

technologies exist. The high cost of genomic sequencing and other molecular technologies remains a limiting factor in the common implementation of these methods for diagnosis and research of rare diseases in resource limited settings. The study of rare genetic diseases in LMICs may be underestimated when compared to large-scale genomic studies performed in developed countries despite being performed under much strained circumstances. Consequently, research publications on the genetics of RDs within LMICs might be underrepresented in the literature, limiting the understanding of genetic and phenotypic variability across populations and contributing to the lack of representation of non-European individuals in genetic studies.
