UNDERSTANDING MEDICAL CODING

MEDICAL CODING IS THE PROCESS OF CONVERTING HEALTHCARE DIAGNOSES, PROCEDURES, AND SERVICES INTO UNIVERSAL ALPHANUMERIC CODES. THESE CODES ARE DERIVED FROM STANDARDIZED CLASSIFICATION SYSTEMS SUCH AS THE INTERNATIONAL CLASSIFICATION OF DISEASES (ICD), CURRENT PROCEDURAL TERMINOLOGY (CPT), AND HEALTHCARE COMMON PROCEDURE CODING SYSTEM (HCPCS). ACCURATE CODING IS CRITICAL FOR PROPER BILLING, STATISTICAL ANALYSIS, AND HEALTHCARE REPORTING.

TYPES OF MEDICAL CODING SYSTEMS
