CERTIFICATE PROGRAMS DURATION

CERTIFICATE PROGRAMS DESIGNED SPECIFICALLY FOR MEDICAL BILLING AND CODING TYPICALLY RANGE FROM 4 TO 12 MONTHS. CERTIFIED CODING SPECIALIST (CCS)

PROVIDED BY AHIMA, THE CCS CERTIFICATION EMPHASIZES INPATIENT AND OUTPATIENT CODING EXPERTISE. CANDIDATES OFTEN PREPARE FOR 6 MONTHS OR LONGER DUE TO THE EXAM'S COMPREHENSIVE NATURE.

CERTIFIED BILLING AND CODING SPECIALIST (CBCS)
