MARYLAND'S HEALTHCARE FACILITIES AND HOME CARE AGENCIES OFTEN REQUIRE SUCH TRAINING TO ENSURE THEIR STAFF ARE QUALIFIED AND COMPLIANT WITH STATE LAWS.

CERTIFICATION AND REGULATORY REQUIREMENTS

STATE REGULATIONS FOR MEDICATION ADMINISTRATION

THE STATE OF MARYLAND HAS ESTABLISHED SPECIFIC GUIDELINES AND REGULATIONS GOVERNING MEDICATION ADMINISTRATION TO ENSURE PATIENT SAFETY AND QUALITY CARE. THESE REGULATIONS APPLY TO A RANGE OF HEALTHCARE PROVIDERS, INCLUDING CERTIFIED NURSING ASSISTANTS (CNAs), HOME HEALTH AIDES, AND OTHER DIRECT CARE WORKERS. COMPLIANCE WITH THESE RULES INCLUDES COMPLETING APPROVED MEDICATION ADMINISTRATION TRAINING PROGRAMS AND OBTAINING CERTIFICATION WHEN REQUIRED. THE MARYLAND BOARD OF NURSING OVERSEES THE ENFORCEMENT OF THESE REGULATIONS AND PROVIDES GUIDANCE ON THE SCOPE OF PRACTICE RELATED TO MEDICATION ADMINISTRATION.

CERTIFICATION PROCESS

OBTAINING CERTIFICATION IN MEDICATION ADMINISTRATION IN MARYLAND GENERALLY INVOLVES COMPLETING AN APPROVED TRAINING COURSE, PASSING A COMPETENCY EVALUATION, AND MAINTAINING ONGOING EDUCATION. THE CERTIFICATION PROCESS

IS DESIGNED TO VALIDATE A CANDIDATE'S KNOWLEDGE AND SKILLS, ENSURING THEY CAN SAFELY ADMINISTER MEDICATIONS IN VARIOUS HEALTHCARE SETTINGS. EMPLOYERS OFTEN VERIFY CERTIFICATION STATUS TO MAINTAIN COMPLIANCE WITH STATE AND FEDERAL REGULATIONS.

1. **RIGHT PATIENT:** CONFIRM THE IDENTITY OF THE PATIENT BEFORE ADMINISTERING MEDICATION.
2. **RIGHT MEDICATION:** VERIFY THE MEDICATION NAME AND FORMULATION.
3. **RIGHT DOSE:** CALCULATE AND MEASURE THE CORRECT DOSAGE ACCURATELY.
4. **RIGHT ROUTE:** ADMINISTER THE MEDICATION VIA THE PRESCRIBED ROUTE (ORAL, INJECTION, TOPICAL, ETC.).
5. **RIGHT TIME:** GIVE THE MEDICATION AT THE CORRECT TIME AND FREQUENCY AS ORDERED.

DOCUMENTATION AND REPORTING

ACCURATE RECORDING OF MEDICATION ADMINISTRATION IS ESSENTIAL FOR CONTINUITY OF CARE AND LEGAL COMPLIANCE. ANY ADVERSE REACTIONS OR ERRORS MUST BE REPORTED PROMPTLY ACCORDING TO FACILITY POLICIES.

ONGOING EDUCATION AND TRAINING

CONTINUOUS PROFESSIONAL DEVELOPMENT ENSURES THAT HEALTHCARE PROVIDERS STAY UPDATED ON NEW MEDICATIONS, TECHNOLOGIES, AND REGULATORY CHANGES AFFECTING MEDICATION MANAGEMENT.
