OVERVIEW OF MEDICARE THERAPY CAP 2023

The Medicare Therapy cap is a financial limit placed on outpatient therapy services covered under Medicare Part B. In 2023, the therapy cap continues to apply to physical therapy (PT), occupational therapy (OT), and speech-language pathology (SLP) services, setting a maximum amount Medicare will pay annually for these treatments. The cap was originally designed to control costs and prevent overuse of therapy services, but it has faced criticism for potentially limiting access to necessary care. Understanding the structure and function of the therapy cap is essential for beneficiaries and providers to navigate coverage effectively.

DEFINITION AND PURPOSE OF THE THERAPY CAP

The therapy cap sets a dollar threshold on covered outpatient therapy services under Medicare Part B. Once a beneficiary reaches this limit, Medicare may suspend payments for additional therapy services unless an exception applies. The cap aims to balance cost containment with appropriate access to therapy, but it requires careful management to prevent disruption in essential rehabilitative care. In 2023, the cap maintains its role as a key component of Medicare's outpatient therapy policy framework.

THERAPY SERVICES AFFECTED

CURRENT THERAPY CAP LIMITS AND UPDATES

FOR THE YEAR 2023, MEDICARE THERAPY CAP AMOUNTS HAVE BEEN ADJUSTED TO REFLECT INFLATION AND UPDATED HEALTHCARE COST DATA. THESE LIMITS REPRESENT THE MAXIMUM AMOUNTS MEDICARE WILL PAY FOR OUTPATIENT THERAPY SERVICES BEFORE TRIGGERING THE EXCEPTIONS PROCESS.

2023 DOLLAR THRESHOLDS

THE MEDICARE THERAPY CAP 2023 SETS THE FOLLOWING LIMITS FOR COMBINED PHYSICAL THERAPY AND SPEECH-LANGUAGE PATHOLOGY SERVICES:

- \$2,230 AS THE STANDARD MONETARY LIMIT FOR COMBINED PT AND SLP SERVICES.
- \$2,230 AS THE SEPARATE LIMIT FOR OCCUPATIONAL THERAPY SERVICES.

THESE THRESHOLDS REPRESENT THE MAXIMUM ALLOWABLE AMOUNTS MEDICARE REIMBURSES BEFORE ADDITIONAL DOCUMENTATION OR REVIEW IS REQUIRED.

ANNUAL ADJUSTMENT FACTORS

The therapy cap amounts are subject to annual adjustments based on the Medicare Economic Index (MEI) or other inflation indexes to maintain alignment with rising healthcare costs. In 2023, these adjustments have resulted in moderate increases compared to previous years, ensuring the cap reflects current economic conditions in the healthcare sector.

EXCEPTIONS PROCESS AND COVERAGE BEYOND THE CAP

The Medicare therapy cap 2023 includes an exceptions process designed to ensure beneficiaries with medically necessary therapy needs continue to receive services beyond the standard cap limits. This process involves documentation and review to justify additional therapy coverage.

This additional step helps prevent misuse while safeguarding access for patients with complex needs. In 2023, this process remains an integral part of managing therapy cap exceptions.

When therapy expenditures exceed the CAP without an approved exception, beneficiaries may face out-of-pocket costs. Awareness of the CAP limits allows patients to plan accordingly and seek assistance when needed. Additionally, therapy providers may adjust treatment plans or billing practices to comply with Medicare policies.

The Medicare therapy cap for 2023 is set at \$2,230 for physical therapy and speech-language pathology services combined, and \$2,230 separately for occupational therapy services.

HAS THE MEDICARE THERAPY CAP BEEN PERMANENTLY REMOVED IN 2023?

AS OF 2023, THE THERAPY CAP HAS NOT BEEN PERMANENTLY REMOVED; HOWEVER, CONGRESS HAS CONTINUED TO DELAY OR WAIVE THE CAP THROUGH TEMPORARY EXCEPTIONS AND REVIEWS TO ENSURE BENEFICIARIES CAN ACCESS NECESSARY THERAPY SERVICES.

WHAT HAPPENS IF A MEDICARE BENEFICIARY EXCEEDS THE THERAPY CAP IN 2023?

If a Medicare beneficiary exceeds the therapy cap in 2023, they can request an exception process by submitting a Medical Review to continue receiving therapy services beyond the cap if medically necessary.

ARE THERE ANY CHANGES TO THE MEDICARE THERAPY CAP POLICY IN 2023?

In 2023, there were no major changes to the Medicare therapy cap policy, but ongoing discussions about reform continue to influence temporary extensions and exception processes.
