DEFINITION AND ROLE OF MEDICATION AIDE

WORK ENVIRONMENTS

MEDICATION AIDES COMMONLY WORK IN RESIDENTIAL CARE FACILITIES, REHABILITATION CENTERS, AND OTHER LONG-TERM CARE SETTINGS. THEIR SCOPE OF PRACTICE CAN VARY DEPENDING ON THE HEALTHCARE FACILITY'S POLICIES AND STATE-SPECIFIC REGULATIONS. IN THESE ENVIRONMENTS, MEDICATION AIDES CONTRIBUTE SIGNIFICANTLY TO PATIENT CARE TEAMS BY ENSURING MEDICATION REGIMENS ARE FOLLOWED SAFELY AND EFFICIENTLY.

TRAINING AND CERTIFICATION REQUIREMENTS

MEDICATIONS THAT FALL WITHIN THE SCOPE USUALLY INCLUDE ROUTINE PRESCRIPTIONS, OVER-THE-COUNTER DRUGS, AND SUPPLEMENTS. MEDICATION AIDES ARE GENERALLY PROHIBITED FROM ADMINISTERING CONTROLLED SUBSTANCES OR INTRAVENOUS MEDICATIONS UNLESS ADDITIONAL LICENSING OR CERTIFICATION IS OBTAINED.

ADDITIONAL DUTIES

BESIDES MEDICATION ADMINISTRATION, MEDICATION AIDES MAY BE AUTHORIZED TO:

- ASSIST PATIENTS WITH SELF-ADMINISTRATION OF MEDICATIONS
- MONITOR AND RECORD PATIENT RESPONSES TO MEDICATIONS

- REPORT DISCREPANCIES OR POTENTIAL MEDICATION ERRORS
- MAINTAIN MEDICATION STORAGE AND INVENTORY

LEGAL AND REGULATORY CONSIDERATIONS

THE MEDICATION AIDE SCOPE OF PRACTICE IS GOVERNED BY STATE LAWS, REGULATIONS, AND HEALTHCARE FACILITY POLICIES. SUPERVISION REQUIREMENTS

THE DEGREE OF SUPERVISION DEPENDS ON STATE LAWS AND FACILITY POLICIES BUT REMAINS A CRITICAL ELEMENT OF THE MEDICATION AIDE SCOPE OF PRACTICE.

DIFFERENCES BETWEEN MEDICATION AIDES AND OTHER HEALTHCARE PROVIDERS
