OVERVIEW AND STRUCTURE OF THE MEDINA BOARD OF EDUCATION

THE MEDINA BOARD OF EDUCATION IS A LOCALLY ELECTED BODY TASKED WITH GOVERNING THE PUBLIC SCHOOL SYSTEM WITHIN THE MEDINA DISTRICT. THEIR COLLECTIVE GOAL IS TO REPRESENT THE INTERESTS OF STUDENTS, PARENTS, AND TAXPAYERS WHILE PROMOTING ACADEMIC ACHIEVEMENT AND FISCAL RESPONSIBILITY.

GOVERNANCE FRAMEWORK

THE GOVERNANCE FRAMEWORK OF THE MEDINA BOARD OF EDUCATION IS GUIDED BY STATE STATUTES AND DISTRICT BYLAWS. ANOTHER CRITICAL RESPONSIBILITY IS HIRING AND EVALUATING THE SUPERINTENDENT, WHO MANAGES THE DAY-TO-DAY OPERATIONS OF THE SCHOOLS.

POLICY DEVELOPMENT AND IMPLEMENTATION

DEVELOPING CLEAR, COMPREHENSIVE POLICIES IS A MAJOR TASK FOR THE MEDINA BOARD OF EDUCATION.
