THESE ACTIVITIES ARE OFTEN ENCOURAGED AS FOUNDATIONAL TO DEMOCRATIC PARTICIPATION AND REPRESENT THE MOST COMMON MEANS BY WHICH CITIZENS EXERCISE THEIR POLITICAL RIGHTS.

UNCONVENTIONAL POLITICAL PARTICIPATION

Unconventional participation includes actions that challenge or operate outside formal political institutions. These forms can be crucial for marginalized groups seeking to draw attention to overlooked issues. Examples include:

SIMILARLY, POLITICAL INTEREST AND AWARENESS MOTIVATE CITIZENS TO BECOME INVOLVED.

DEMOGRAPHIC CHARACTERISTICS

AGE, RACE, GENDER, AND ETHNICITY ALSO SHAPE PARTICIPATION PATTERNS. FOR EXAMPLE, OLDER CITIZENS HISTORICALLY VOTE AT HIGHER RATES THAN YOUNGER ONES, WHILE MINORITY GROUPS MAY FACE UNIQUE BARRIERS THAT AFFECT THEIR INVOLVEMENT.
