THEORETICAL FOUNDATIONS OF HEALTH EDUCATION

THE THEORETICAL FOUNDATIONS OF HEALTH EDUCATION PROVIDE A SCIENTIFIC BASIS FOR UNDERSTANDING HEALTH BEHAVIORS AND GUIDING THE DEVELOPMENT OF EFFECTIVE EDUCATIONAL PROGRAMS. HEALTH BELIEF MODEL

SOCIAL COGNITIVE THEORY

SOCIAL COGNITIVE THEORY EMPHASIZES THE ROLE OF OBSERVATIONAL LEARNING, SELF-EFFICACY, AND RECIPROCAL DETERMINISM IN BEHAVIOR CHANGE. IT HIGHLIGHTS THE DYNAMIC INTERACTION BETWEEN PERSONAL FACTORS, ENVIRONMENTAL INFLUENCES, AND BEHAVIOR.

TRANSTHEORETICAL MODEL

RESPECT FOR AUTONOMY AND INFORMED CONSENT

HEALTH PROMOTION INITIATIVES MUST HONOR INDIVIDUALS' RIGHTS TO MAKE INFORMED DECISIONS ABOUT THEIR HEALTH. THIS INCLUDES PROVIDING CLEAR, ACCURATE INFORMATION AND OBTAINING CONSENT FOR PARTICIPATION IN PROGRAMS OR RESEARCH.

CULTURAL COMPETENCE AND SENSITIVITY

EVALUATION AND MEASUREMENT ARE CRITICAL COMPONENTS THAT ASSESS THE EFFECTIVENESS AND IMPACT OF HEALTH PROMOTION AND EDUCATION INITIATIVES. SYSTEMATIC EVALUATION INFORMS PROGRAM IMPROVEMENT, ACCOUNTABILITY, AND EVIDENCE-BASED DECISION-MAKING.

TYPES OF EVALUATION

EVALUATION CAN BE FORMATIVE, PROCESS, IMPACT, OR OUTCOME-BASED. FORMATIVE EVALUATION GUIDES PROGRAM DEVELOPMENT, PROCESS EVALUATION MONITORS IMPLEMENTATION, IMPACT EVALUATION ASSESSES IMMEDIATE EFFECTS, AND OUTCOME EVALUATION EXAMINES LONG-TERM CHANGES IN HEALTH STATUS.
