THE SWORN NATURE OF THE STATEMENT IMPLIES IT IS MADE UNDER OATH, OFTEN REQUIRING NOTARIZATION OR OFFICIAL WITNESSING, WHICH ADDS A LAYER OF LEGAL RESPONSIBILITY AND AUTHENTICITY.

WHO PREPARES THE STATEMENT?

HOWEVER, PROJECT OWNERS OR ARCHITECTS MAY ALSO REQUEST OR PREPARE THESE DOCUMENTS TO VERIFY PROGRESS OR CERTIFY PAYMENTS. THE STATEMENT IS OFTEN SUBMITTED DURING PROJECT MILESTONES OR AT PROJECT COMPLETION.

KEY COMPONENTS OF A SWORN CONSTRUCTION STATEMENT TEMPLATE

6. **SIGNATURE AND NOTARIZATION:** SPACE FOR THE DECLARANT'S SIGNATURE, DATE, AND NOTARIZATION OR WITNESS CERTIFICATION TO VALIDATE THE SWORN STATEMENT.

ADDITIONAL SECTIONS
