# JOHN T. SCOPES: THE TEACHER IN QUESTION

JOHN THOMAS SCOPES WAS A YOUNG SCIENCE TEACHER AND FOOTBALL COACH AT A HIGH SCHOOL IN DAYTON, TENNESSEE. HIS ROLE IN THE 1925 TRIAL WAS CENTRAL, AS HE WAS THE INDIVIDUAL CHARGED WITH VIOLATING THE BUTLER ACT BY TEACHING EVOLUTION.
