Savala offers an angle to inequities that is as deft as it is lyrical. In Bad Education we mine how women learn to internalize violence and rage in hopes of truly having power. Over and over again, Savala reminds readers that our true identities are often most authentically lived not in the black and white in the grey, in the in-between.
