CONFIDENTIALITY AND PRIVACY

MAINTAINING CONFIDENTIALITY IS CRITICAL IN BUILDING TRUST BETWEEN SOCIAL WORKERS AND CLIENTS. SOCIAL WORKERS MUST SAFEGUARD CLIENT INFORMATION, SHARING IT ONLY WHEN LEGALLY REQUIRED OR WITH CLIENT CONSENT.

INFORMED CONSENT

ACTIVE LISTENING

ACTIVE LISTENING INVOLVES FULLY CONCENTRATING, UNDERSTANDING, AND RESPONDING THOUGHTFULLY TO CLIENTS. THIS TECHNIQUE HELPS SOCIAL WORKERS IDENTIFY UNDERLYING ISSUES AND DEMONSTRATES RESPECT FOR THE CLIENT'S PERSPECTIVE.

NONVERBAL COMMUNICATION

Nonverbal cues such as body language, eye contact, and facial expressions play a significant role in conveying empathy and attentiveness. Skilled social workers interpret and use nonverbal signals to enhance communication.

CLARIFICATION AND SUMMARIZATION

CLARIFYING INFORMATION AND SUMMARIZING DISCUSSIONS ENSURE MUTUAL UNDERSTANDING. THESE TECHNIQUES HELP IN CONFIRMING CLIENT CONCERNS AND PLANNING APPROPRIATE INTERVENTIONS.

EMPATHETIC RESPONSES

RESPONDING WITH EMPATHY VALIDATES CLIENTS' FEELINGS AND EXPERIENCES, FOSTERING A SUPPORTIVE THERAPEUTIC ENVIRONMENT. EMPATHY ENHANCES THE SOCIAL WORKER-CLIENT RELATIONSHIP AND PROMOTES CLIENT ENGAGEMENT.

INCLUSIVE PRACTICE STRATEGIES
